TENANCY AGREEMENT FOR RAISED BEDS

All tenants must abide by the following rules. Failure to comply will lead to the tenant's raised bed being re-allocated.

- 1. Tenancy agreements will run from 1 st February until 31 January.
 - (a) Individual tenants will have a term of one year after which they can reapply (acceptance dependent upon availability).
 - (b) Local community groups will also have a tenancy of one year but this will automatically renew if requested and providing that they have abided by the terms of the agreement.
 - (c) New applications will be given priority over tenants who reapply after 2 consecutive years.
 - (d) When possible tenants are expected to attend at least 2 volunteer sessions a year to help keep the communal areas well maintained and/ or to volunteer for public events.
- 2 Payment of rent must be made by 31 St December of the preceding year in order to secure the tenancy.
- 3 All tenants must be paid up members of the Grapes Hill Community Gardening Group (GHCGG).
- 4 All growing within the garden is to be done along the lines of organic cultivation this does not allow the use of chemical pesticides, herbicides or fertilisers.
- 5 The raised beds are to be used solely for the cultivation of annual vegetables, fruits, herbs and other plants that are considered edible. Perennial varieties are not allowed.
- 6 Tenants will be responsible for supplying their own seed, plants, tools, plant supports, etc.
- 7 Tenants are solely responsible for the planting, cultivation, weeding and watering of their raised bed.
- 8 Raised beds should be well maintained. This means reasonably weed-free, tidy and kept as productive as possible. Tenants are also requested to weed the paved area surrounding their raised beds on a regular basis.
- 9 Tenants should bear others in mind when working on their raised bed, keeping a safe, tidy and pleasant environment within the garden for other users and visitors. Any mess (e.g. spilled soil, plant debris, etc.) should be cleared away when you finish working.
- 10 Tenants must clear their raised bed of all vegetation, plant supports, etc. prior to the end of their tenancy on the 31st January.

11 If a tenant is experiencing problems with the upkeep of their bed, they should contact the GHCGG as soon as possible in order to see if any help can be given.

If a raised bed appears not to be being cultivated or is left in an untidy/weedy condition for more than 4 weeks, the GHCGG reserves the right to tidy it up and remove weeds, and may well re-allocate the bed but only after communicating with the tenant and giving a time limit in which to rectify any problems.

- 12 If a tenant opts to relinquish their raised bed part way through the year, no refund can be given. Similarly, if a tenant is evicted for non-compliance of these rules and regulations, no refund will be made.
- 13 The garden will be open daily to the general public as well as members of the GHCGG and tenants of the raised beds, but locked at night.
- 14 The Grapes Hill Community Garden Group will not be liable for any loss or damage to the contents of the raised beds.
